- **Yarrow** – In the herbal tradition, Yarrow assists normal purification processes, removes excess "heat" and can stimulate normal flow of regulatory fluids.
- **Stevia** – Best known as a natural, non-sugar sweetener of beverages and baked goods, Stevia is a traditional South American botanical that supports normal immune and glucose metabolic activities.
- **Calcium Carbonate** – Essential for the body to appropriately absorb calcium. Used in this context as a "botanical binding" ingredient.
- **Tayuya** – A famous rain forest botanical used for thousands of years in South American herbology and Brazilian hospitals. Cited to be purifying.
- **Gravel Root** – Often employed in traditional herbology as supportive of normal kidney and gall bladder processes. Cited in herbal texts to support the body's normal purifying activities.
- **Pimpinella** – Provides anethole (anise like flavor). Herbalists employ Pimpinella for a wide variety of uses to support normal immune, muscle, and hormonal balance.

▼ BACKGROUND

Doc Wheelwright searched for many years to find a way to properly employ the herb, Yarrow, because of ancient text references. He classified Yarrow as a "poly-ionic" herb meaning that it was simultaneously catabolic and anabolic (cationic and anionic.) Polyionic herbs are often known as *adaptogens*. In Doc's system of herbology, poly-ionic herbs were difficult to work with in combination with other herbs. The Imperial Ataker and the ATAK formulas were major breakthroughs in his research and he conducted several experiments with the ATAK formula. Doc taught that most people don't die of new diseases; they die from all the diseases that they acquired during their lifetimes that become "intranoidal" diseases, e.g. mutated variants that take up residence in the body's extracellular matrix that "activate" e.g. quorum sense and become more pathogenic later in life when the immune system is weakened. Doc recommended periodic "Purification Support" to help the body from the burdens incurred via the daily immunological preoccupations.
