▼ **DOSAGE**

Designed to lend gentle assistance to the body's normal purification processes by supporting the liver's innate tissue integrity, and by providing nutrients the liver uses to accomplish its Phase 1, 2 & 3 metabolic processes. Provides liver-centric herbal chelators and supporters of the inherent purification activities that help remove acquired environmental metals and chemicals, as well as metabolic wastes.

- Daily, normal purification activity support
- Support normal liver activities
- Drainage support
- Extracellular matrix purification support
- General liver vitality

▼ **KEY COMPONENTS**

- **Dandelion** – An herb with a long history of supporting normal liver, lymph and blood processes. Contains many biologically-active compounds such as terpenes, sterols, polysaccharides, fatty acids and flavonoids.
- **Pfaffia** – “Energizing adaptogen,” provides botanical molecules that support the normal, healthy immune and energy metabolic processes.
- **Cinquefoil** – An herb with an established history of supporting normal lymphatic and liver processes with botanical “purifying agents” that support normal metabolic pathways.
- **Milk Thistle** – A hugely popular and massively researched liver tonic herb. Research shows it supports normal intercellular protein synthesis, and protects the liver via antioxidants. Often cited to aid the liver with day-to-day activities.
- **Mountain Mahogany** – One of Doc Wheelwright's little-known, well-researched and favorite herbs to support the body's normal, innate purification mechanisms.
- **Yucca** – From the Native American herbal tradition, yucca serves to support normal blood purification via saponins that help with the natural lipid regulatory pathways; provides nascent Vitamin C and Potassium; and often used as kidney drainage support.
- **Wahoo** – An herb shown to support the normal free-flow of bile which is one of the body's chief avenues of removing unwanted metals and chemicals. Historically supports normal liver processes.
- **Urea** – Carbamide. A molecule that supports kidney and liver function by providing a ready source of nitrogen.
- **Bitter Almond** – An herb that contains amygdalin which supports normal mucous membrane function.
- **Vitamin E** – Antioxidant, helps improve immunity levels.
- **L-Methionine** – A sulfur-based amino acid that supports the normal production sulfur compounds, as well as phospholipids in the liver. Metabolically protective regarding normal liver processes of converting heavy metals for expulsion. Supports normal fatty acid metabolic processes.

▼ **CONTRAINDICATIONS**

Best to not engage detoxification programs during pregnancy or in the first six months of nursing.

▼ **BACKGROUND**

Doc Wheelwright established the fundamentals of safe and effective purification processes with his “Liver Lifeline” program of building the liver to detoxify the entire body. He wanted a formula that would serve 4 purposes: 1) support the normal mobilization of unwanted metals and compounds from adipose storage to purification channels; 2) support normal drainage pathways (safe escort to exit portals); 3) gently encourage normal liver purification activities; 4) ability to use daily to help the body's innate, natural purification processes to help counter in increased demands of the air quality, chemicals in drinking water, and pesticides in commercial foods. He employed concepts regarding chelation and drainage for safe egress of xenobiotic substances, as well as normal metabolic wastes.
