- **Pau d'Arco** – While most famous for its ability to grow without fungus on its bark in the wet Amazon basin, Pau d'Arco has a blood sugar process stabilizing impact when already in the normal range.
- **Pancreas RNA/DNA Factors** – Specific support for the pancreas’ cellular identity and tissue integrity via organized amino acids, peptides, and nucleoprotein structures.
- **Rose Hips** – A natural source of whole complex Vitamin C with synergistic factors.
